SUBJECT: Nominations – Zoning Board of Adjustment

SUMMARY:

The Zoning Board of Adjustment is charged with reviewing and granting or denying applications for variances and special exceptions to the Land Development Code. The board also hears and decides appeals when it is alleged that there is error in any order, requirement, decision, or determination made by an administrative officer in the enforcement of the Land Development Code. **MEMBERS MUST BE RESIDENTS OR PROPERTY OWNERS OF THE CITY OF PENSACOLA.**

The Board is composed of nine (9) members appointed by the City Council for a term of three years. Terms are staggered, with three positions requiring appointment/reappointment each year.

The term of Georgia Blackmon, Patrick Boudreaux, and Randy Oglesby will expire July 14, 2015. Of the three incumbents, Mr. Boudreaux wishes to be considered for reappointment.

Attached for Council's review is Mr. Boudreaux's attendance record and a list of the Zoning Board members. Nomination forms are also attached for Council's use.

Nomination forms should be submitted to the City Clerk's office by 12:00 Noon, Thursday, July 2, 2015 for consideration at the July 16, 2015 City Council meeting.
