**SUBJECT:** Nominations – Architectural Review Board

**SUMMARY:**

The Architectural Review Board approves or disapproves plans for buildings to be erected, renovated, or razed which are located, or to be located within the historic districts, preservation districts and Governmental Center District.

The Architectural Review Board is composed of seven members appointed by City Council, two from the West Florida Historic Preservation, Inc., each of whom shall be a resident of the City of Pensacola; one member from the City Planning Board or resident property owner of the Pensacola Historic District, North Hill Preservation District or Old East Hill Preservation District; two registered architects, each of whom shall be a resident of the City of Pensacola; one member who is a resident of the Pensacola Historic District, North Hill Preservation District or Old East Hill Preservation District; and one member who is a property or business owner in the Palafox Historic Business District or the Governmental Center District. These appointments are for a term of two years.

The term of Nina H. Campbell, representative from the Planning Board; Susan Campbell, business owner in the Palafox Historic Business District; and George R. Mead, II, resident of North Hill Preservation District, will expire September 30, 2015. All would like to be considered for reappointment.
